1. Welcome, Land Acknowledgement, and Declaration of Quorum – Polly Raymond, President
2. Call to Order –
 - Approval of 2024 agenda and minutes from last AGM

4. 2024 Financials / Exec Report – Lynda Ferris, ED
 - Presented 2024 year-end financial statement (as attached)

 - Year in review:
 - o Funding received from Community Service Recovery Fund provides for redevelopment of a new CPS website. Building of the website is underway. New platform will include a membership platform and easier avenue for people to donate and for CPS to coordinate volunteers.
5. Grants and Funding – Lynda Ferris, ED
 - Formalized trail sponsorship program - 3 Community Forest, 1 LQ Park, 3 Little Mountain
 - Partnerships - Skowkale First Nation and RSTBC, funding from both to support trail crew
 - Grant writing
 - o BC Gaming Grant funds
 - Community Grant - \$6400
 - Service club funding - Dogwood Monarch Lions, Elk, Cheam Lions
 - o TCT - trail crew funding \$4500
6. Field Trip Program – Kylie Greidanus, Field Trip Coordinator and Treasurer
 - The field trip program for Spring 2025 is almost fully booked up.

- With additional grant funding will be able to hire another field trip program coordinator/teacher – will increase field trip experience with the ability to break into smaller group sizes.

7. Summer Trail Crew Report – Marc Greidanus

- A lot of trail work was completed this year at the community forest
- CPS Trail crew partnered with RSTBC for some trail work – has been a great partnership and completed a lot of work at Rolly Lake and Devil's lake.
- Trail Crew not in attendance but a crew report was provided and passed around. Attached to the minutes for reference.

8. Little Mountain – Polly Raymond and Marc Greidanus

- Model of Little Mountain is complete and has made the rounds to various events and trail days. A table to hold the model would be helpful for the display.
- Advocacy work continues with the City of Chilliwack and the developer for the expansion of Little Mountain Park.
- Trail work near the water tower is ongoing.

9. Community Forest/LQ/Qoqó:lem -

- Trails in community forest are running great. Many leaves are currently on the trail, so users are being encouraged to help rake and clear the trail. Rakes and trail maintenance equipment are being strategically placed along trails.
- A lot of structure work is taking place on Playground and Upper Alhqéy trails. Almost ready to open the section with the new wood features.
